



## Rubber Mat Classic 3/4 Inch Straight Edge Mats Manufacturer’s Limited Warranty

Greatmats provides this limited warranty from the manufacturer (the “Seller”) who warrants that Rubber Mat Classic 3/4 Inch Straight Edge Mats (the "Product") offers the following limited warranty on the Rubber Mat Classic 3/4 Inch Straight Edge Mats produced for equine use products:

1. The manufacturer warrants that all products it supplies will meet the applicable product specifications specified by the manufacturer and will be free from defects in material and workmanship at the time of shipment from the manufacturer and for 5 years (the “Initial Warranty Period”) thereafter. If defects appear during the Initial Warranty Period, the manufacturer will, at its sole option and as the customer’s exclusive remedy, repair or replace the defective product. If there are defects in material and workmanship subsequent to the Initial Warranty Period and up to fifteen (15) years from the date of delivery, the manufacturer will replace the products and charge the customer the following amounts based on current prices (plus tax) at the time of replacement:

Note: The rate of wear of 3/4” is directly connected to the volume of traffic and use. Any warranty calculations will take this into account.

2. The Warranty only applies provided that the manufacturer receives written notice (mailed to address below) of the defect along with proof of purchase. To claim under the Initial Warranty Period, the receipt of the required information by the manufacturer must be within ten (10) days of the end of the Initial Warranty period.

3. This Warranty applies to materials only and does not include any other cost, such as delivery, installation, removal or labor costs. This warranty is not transferable.

4. Any defect determined by the manufacturer not to be due to a defect caused by the manufacturer (e.g., if it is attributable to alteration, modification, negligence or misuse by the customer or another person) is not covered by this Warranty. The normal wear and aging of your product due to normal usage is not covered by this Warranty.

5. THIS IS THE ONLY WARRANTY OFFERED BY THE MANUFACTURER. THE MANUFACTURER EXPRESSLY DISCLAIMS ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

6. Designs, data, and other technical information supplied by the manufacturer are supplied "AS IS" and are not covered by this or any other warranty, except as expressly stated otherwise in writing by the manufacturer.

7. The manufacturer has no control over how its products and technology will be used by its customers. The manufacturer does not make any representations or warranties that its products or technology will work in specific applications.

8. IN NO EVENT WILL THE MANUFACTURER BE LIABLE FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, INCLUDING LOST PROFITS, LOSS OF USE OR OTHER ECONOMIC LOSS. IN NO EVENT WILL THE MANUFACTURER'S LIABILITY UNDER THIS WARRANTY EXCEED THE AMOUNT PAID BY THE CUSTOMER TO THE MANUFACTURER FOR THE PRODUCT AT ISSUE.
